



# I. Description of Equipment

This equipment consists of a mechanical bearing-equipped, single-position turntable for manual rotation with pneumatic brake for locking rotation.


Corner locators

90 degree spring lock pin




180 degree spring lock pin

# V. Setup Instructions

- 1. Remove unit from truck with fork truck.
- 2. Place in desired location making sure floor is level within 1/4" over surface area of base. If not, shim to level with building paper or metal shims in built-up layers to attain level. Once the floor is level, lag unit to the floor.

Note: Remove shipping bolts from turntable before rotating. Use these bolts to transport the turntable within the plant if and when necessary.




#### VI. Operating Instructions

**To Rotate:** Manually rotate turntable to desired position.


**If shipped with optional pneumatic brake:** Turn brake off before rotating. Stop turntable in any position by actuating brake.

If shipped with optional mechanical locking pin: Release lock before rotating.



#### VII. Service and Maintenance

**Every six months:** Lubricate mechanical bearing with MP grease. Bearing has two grease zerk fittings located 180° apart.
